PREAMBLE:

The notation '[NP]' (No Protest) in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a).

The notation "[SP]" in a rule in the SI means that a breach of that rule denotes a rule may, at the discretion of the race committee, be a standard penalty without a hearing or, a discretionary penalty applied by the International Jury with a hearing.

1.RULES

The event is governed by:

- 1.1 The rules as defined in the current "Racing Rules of Sailing" (RRS)
- 1.2 The ITA Class Rules and "Appendix C International Events" and the "Equipment Inspection Regulations" will apply.







- 1.3 A boat chartered or loaned for the event may carry national letters or a sail number in contravention of the class rules (see RRS Appendix G.3).
- 1.4 In case of translation of any document, if there is a conflict between languages, the English text will take precedence.
- 1.5 Appendix P is not applied

2. SAILING INSTRUCTIONS

2.1 Sailing Instruction will be available upon confirmation of registration and from the 16th of August at the Race Office, or on the FIV portal: https://federvela.coninet.it

3. COMMUNICATION

- 3.1 The Official Notice Board can be found near the Race Office and possibly on the WhatsApp group of the event.
- 3.2 **[DP] [NP]** Except in an emergency, a boat that is racing shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

4. ELIGIBILITY AND ENTRY

- 4.1 The event is open to the INTERNATIONAL TORNADO CLASS boats.
- 4.2 Documents required for registration:
- 4.2.1 Italian competitors shall be member of the Italian National authority with a valid medical certificate and a valid third-party liability insurance with a minimum cover of 1,5 million Euros or the FIV PLUS Option;
- 4.2.2 Foreign Competitors shall be in compliance with their own National Authority and must be covered by a valid third-party liability insurance with a minimum cover of 1,5million Euros;
- 4.2.3 Minors: shall be allowed by the Parents or tutor to participate in sailing competition, downloading and signing the Parental Authorization at Attachment C of this NOR. The form must be sent by email to tornado.worlds2023@centroveladervio.it
- 4.2.4 All the competitors may be in compliance with the ITA membership;
- 4.2.5 Eligible boats shall have valid Measurement Certificates that comply Class Rules.
- 4.3 Eligible boats may enter compiling the form published on the regatta's pages:
- 4.3.1 The Italian sailors on the FIV portal https://federvela.coninet.it/#/manifestazioni/58403/iscrizioni, who shall also upload on the page the Measurement Certificates and the third party liability insurance policy (insurance policy is not necessary in case of FIV PLUS option);
- 4.3.2 For the foreigner sailors on the FIV portal https://federvela.coninet.it/iscrizioniatletistranieri
- 4.4 Support persons and coaches vessels may enter compiling the form at Attachment D of this NOR
- 4.5 All the registrations will be completed paying the registration fee by Bank Transfer in Euros. No other currencies will be accepted







- 4.6 An email shall be send to tornado.worlds2023@centroveladervio.it after the payment of the registration fees. The mail shall be have subject "Tornado Worlds Championship 2023 <sail_number> documents" and contain a copy of the following documents:
 - 4.6.1 Crew's ITA Membership cards;
 - 4.6.2 Measurement Certificates that comply Class Rules;
 - 4.6.3 Support person vessels entry form, if any;
 - 4.6.4 Minor competitors only: Parental Authorization;
 - 4.6.5 Foreign competitors only: Membership cards of their National Authority;
 - 4.6.6 Foreign competitors only: third party liability insurance policy.
- 4.7 To be considered entered to the Event, a boat must be fully paid, Eligible and fully compliant with the requested documents

5. ENTRY FEES

5.1 Entry fee per boat:

- Early entries From the date of this NOR until July 15th: 450 € per boat;
- Late entries From July 16th until August 15th: 550 € per boat.

The Entry fees includes the following benefits:

- cars and boats park
- 1 T-shirt for competitor (T-shirt for family members and friends at 10,00 €/each)
- Access to the opening and closing ceremonies (for all)
- Official dinner for crews (family members and friends at 25,00 €/each)
- After daily races 1 drink and finger food for crews only (family members and friends at 5,00€/each)

5.2 Support person vessels entries:

- Early entries support people: until July 15th, the entry fee is € 25,00
- Late entries: From July 16th until August 15th, the entry fees will be € 35,00.

6.1 [DP] [NP] Boats may be required to display advertising chosen and supplied by the Organizing Authority in accordance with Regulation 20.4.1 and CR 1.24.

- 7.1 Total Number of races: 10 races are scheduled for the regatta
- 7.2 On the last day of the regatta no warning signal will be made after 15:00.

8. EQUIPMENT INSPECTION

- 8.1 Equipment Inspection shall be conducted in accordance with the Tornado Equipment Inspection Regulations.
- 8.2 Each boat shall present a valid measurement certificate at Equipment Inspection
- 8.3 All boats must be kept at the regatta site commencing at the time of registration and continuing until the end of the event. Removal of any boat from the regatta site during the event shall require prior written permission from the equipment inspector.
- 8.4 A boat or equipment may be inspected at any time for compliance with the Class Rules, Equipment Inspection Regulations and Sailing Instructions. On the water a boat may be instructed by the equipment inspector to proceed immediately to a designated area for inspection.

9. REPLACEMENTS OF CREW OR EQUIPMENT

- 9.1 Substitution of competitors will not be allowed without prior written approval of The Race Committee, and only the case of sickness, accident, or special circumstances.
- 9.2 Substitution of damaged or lost equipment will not be allowed unless authorized by the Technical Committee, and that the equipment inspector deems to be damaged beyond repair. Requests for substitutions shall be made to the Technical Committee at the first reasonable opportunity. Replaced equipment must measure within the Class Rules.







10. VENUE

- 10.1 NOR attachment A "Venue" shows the location of the Centro Vela Dervio A.S.D. Sailing Club.
- 10.2 The Boat Park will be located at the venue of C.V.D.

11. RACING AREAS

11.1 NOR Attachment B "Areas" shows the racing areas of the Regatta, between Dervio and Pianello Lario

12. COURSES

12.1 The Courses will be windward/leeward as shown in class rules Appendix C (see Sailing Instructions for details)

13. PENALTY SYSTEM

- 13.1 The 2 turn penalty is changed to 1 turn penalty. This modifies RRS 44.1.
- 13.2 Decision of the International Jury will be final as provided in rule 70.5

14. SCORING

- 14.1 Four races are required to be completed to validate the regatta.
- 14.2 When 4 races or less have been completed, a boat's series score will be the total of her race scores.
- 14.3 When 5 races or more have been completed, a boat's series score will be the total of her race scores excluding her worst score.

15. SUPPORT PERSONS VESSELS

- 15.1 All support persons vessels shall be required to comply with local legislation and event support vessels regulations. The organizing authority may refuse registration and accept later registration at their sole discretion. The support persons vessel shall register at the Race Office at Registration time before the first start.
- 15.2 All support boats shall clearly always display the 3 letters of the national code of their WS Member national Authority while afloat.
- 15.3 Support persons vessels with team leaders, coaches and other support person shall stay outside areas where boats are racing from the time of the starting sequence until all boats have finished, or the race committee signals a postponement, general recall, or abandonment.
- 15.4 In the event of an emergency the Race Committee may request support vessels for their assistance (RRS Race signals, Flag V).

16. PRIZES

16.1 Prizes will be given as follows:

- Tornado Open: to the first 5 classified boats;
- Tornado Mixed: to the first 3 classified boats;
- Tornado Youth: to the first classified boat.







17. RISK STATEMENT

17.1 RRS 3 states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone". The participants are aware that the sailing activity falls within those governed by article 2050 of the Italian Civil Code therefore all Italian participants must have a valid FIV membership, included medical validation, that guarantees accident coverage, including death and permanent disability.

Foreigner competitors must comply with the requirements of their MNA, if any, and be in possession of accident coverage, including death and permanent disability as per current FIV regulations.

18. ENVIRONMENTAL RESPONSIBILITY

18.1 It is recalled the Basic Principle which states: "Participants are encouraged to minimize any adverse environmental impact of the sport of sailing", it is recommended that care be taken to protect the environment at all times during and after the event. Especially attention is drawn to RRS 47 -TRASH DISPOSAL- which states: "Competitors and support persons shall not intentionally put trash in the water. This rule applies at all times while afloat. The penalty for a breach of this rule may be less than disqualification".

19. DATA PROTECTION

19.1 Right to image and appearance: By participating in this competition, each competitor and his legal representatives authorize the OA, and its partners to use their image and name free of charge, to show at any time (during and after the competition) moving or static photos, films or television recordings, and other reproductions of itself taken during the competition, and this in any medium and for any use related to the promotion of their activities.

19.2 Use of participants' personal data. By participating in this competition, the competitor and his legal representatives' consent and authorize C.V.D. and its sponsors to use and store their personal data free of charge. These data may be published by the C.V.D. and its sponsors. C.V.D. in particular, but also its sponsors may use this data for software development or for marketing purposes. In accordance with the General Data Protection Regulations (RGPD), any competitor who has communicated personal data to the C.V.D. may exercise his right of access to data concerning him, have them rectified and depending on the situation, delete them, limit, and oppose it, by contacting the C.V.D., specifying that the request relates to personal data.








Tornado World Championships 2023 NOR Attachment A "Venue"

How to get there...









It is very easy to reach the location from the different European cities. These are the travel distances from some important place:

- 1. 85 km from Milan Downtown and a little bit more from Milano-Linate Airport
- 2. 107 km from Milano-Malpensa Airport
- 3. 72 km from Orio al Serio Airport (Bergamo)
- 4. 50 km from COMO Brogeda (Swiss border/Highway)
- 5. 80 km from St. Moritz
- 6. 300 km from Zurich
- 7. 390 km from Brenner
- 8. 850 km from Vienna
- 9. 550 km from Munich
- 10. 930 km from Paris.

How to reach Dervio from Milano

- 1. take the motorway SS 36 del Lago di Como e dello Spluga towards Lecco and Sondrio.
- 2. after about 25km from Lecco, exit at Dervio.
- 3. go down towards the lake, above the railway line and above the traffic-light (it is the only one at Dervio)
- 1. **for whom arrive from South on** *SP 72 del Lago di Como*, at the traffic-light in *Dervio*, turn on the left
- 2. **for whom arrive from North on** *SP 72 del Lago di Como*, at the traffic-light in *Dervio*, turn on the right
- 4. take the second road left in via Don Luigi Penati
- 5. then immediately right in via degli Alpini
- 6. then on left again in via alla Darsena
- 7. drive straight on, alongside the lake, in via degli Ulivi up to Centro Vela Dervio.

Another chance, more panoramic, but slower (you'll drive across a lot of villages)

- 1. take the motorway SS 36 del Lago di Como e dello Spluga towards Lecco and Sondrio.
- 2. about 2,5 km after the long tunnel under the city of Lecco, exit towards *Varenna / Mandello / Abbadia L.* (you'll take *SP 72 del Lago di Como*)
- 3. straight on towards Sondrio up to Dervio
- 4. at the traffic-light, turn on the left and follow the instructions of the previous route from point 4.








Map of the way to reach the Trailer Park "Parcheggio"
